

SCOTTISH GOLF R&A 9-HOLE CHAMPIONSHIP

CONDITIONS OF COMPETITION

1. Eligibility

The R&A 9-Hole Championship is open to all members of Scottish Golf affiliated clubs meeting the following criteria:

- Are of amateur status as defined by R&A Rules Limited.
- Are in possession of a CONGU competition handicap.
- Only represent 1 Golf Club in the National Final.

2. General

- Open to all Scottish Golf affiliated clubs who have a designated 9-Hole standard scratch score.
- All stages run in accordance with R&A Rules of Golf and in conjunction with the club's own local rules.
- All clubs are invited to schedule 9-Hole qualifying competitions and submit 1 leading pair to the National Final.
- Club qualifying competitions may be standalone 9-Hole fixtures or attached to an existing 9-Hole competition.
- Members of more than 1 club may compete in the qualifying round at each affiliated club where they are a member, but may only represent 1 golf club should they qualify for the National Final.
- [Ready Golf](#) will be encouraged at all stages of the championship.

3. Format

Club Qualifying

- All stages will be played as 9-Hole stableford played on 1 day.
- Event will be contested in pairs which may be male, female or mixed but only include a maximum of 1 U18 player.
- Pairs must be nominated before play and if competing in same group must not give advice or mark each other's card.
- A player's 9-Hole handicap allowance will be calculated by your club system's software using the following formula.
[Exact Handicap + Nine-Hole SSS – (Nine-Hole Par x2)] / 2.
- The team score is calculated from the combined stableford points of both players.
- The committee is responsible for running the qualifying round and deciding ties at their club.
- The leading 1 club pair from each club will qualify for the National 9-Hole Final at Milnathort Golf Club on Friday 15 June 2018.
- In the event of the National Final becoming over-subscribed Scottish Golf reserve the right to schedule an additional day.

National Final

- In the event of a tie for the top 4 pairs at the National Final, the qualifiers and ordering of subsequent reserve places will be decided by card count back based on the team stableford scores over the last 6 holes (or 3 or 1). If a tie still arises a card play-off from the 1st hole will apply, failing which; the qualifiers and subsequent reserve places will be decided by lot.
- In exceptional circumstances e.g. in the case of inclement weather, Scottish Golf reserves the right to amend the format and any conditions pertaining to the National Final as it sees fit in order to achieve a result.
- All disputes will be decided by Scottish Golf whose decision will be final.
- The leading 4 pairs from the National Final will advance to the 9-Hole Grand Final which will take place at Carnoustie on Saturday 14th July where Scottish qualifiers will compete against successful pairs from England, Ireland and Wales.

N.B. Grand Final related correspondence will be communicated via the R&A directly to the finalists' clubs.

4. Entries

- All clubs must submit their leading club pair's score to Scottish Golf by the closing date.
- It is the entrant's responsibility to ensure their handicap is correct if entering via Centralised Database Handicap (CDH)
- Correspondence will be sent to the club email address provided at time of entry a min. of 2 weeks prior to the Grand Final.
- Scottish Golf will not be responsible for any correspondence that fails to reach competitors.

- e) Scottish Golf reserves the right to refuse any championship entry.
- f) In the event of the National Final becoming over-subscribed Scottish Golf reserve the right to schedule an additional date.

5. Withdrawals

Withdrawals will only be accepted when written confirmation is received by events@scottishgolf.org.

6. Registration

ALL teams must register on the day at the Scottish Golf registration desk at least 30 minutes prior to their start time. Failure to do so may result in a team forfeiting their place in the field.

7. Substitutions

National Final

In the event of a player(s) being unable to compete substitutions are permitted.

Grand Final

In the event of a player (s) being unable to compete, the next available pair from the National Final will be invited.

8. Policies & Procedures

- f) The specimen conditions in the Rules of Golf (Pages 154 - 156) are in effect regarding conforming driver heads and conforming golf balls.
